The letter of resignation received from Ms. Nirupama Charuhas Khandke is enclosed herewith.

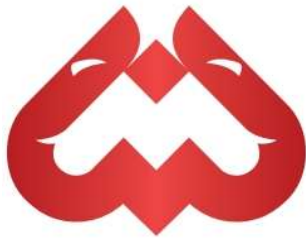
